School Board Members Needed for Adequacy Study (Urgent Request)

Colorado School Finance Project is looking for board members to sit on panels with other education leaders to support its work around determining what adequate funding of schools in Colorado should be.

The evidence-based (EB) approach, which you are being asked to be part of, is a virtual panel that will require 4 hours of your time and you will meet with 5-8 others to identify the resources representative schools need in order to ensure that all students can meet state standards and requirements. Background: Augenblick, Palaich and Associates, Inc. (APA), a Denver-based consulting firm, will be working in partnership with Picus, Odden & Associates (POA), Afton Partners (Afton), and Colorado school finance expert Tracie Rainey to conduct the Colorado Input Based Financial Adequacy Study for the Colorado Department of Education (CDE). The study team will implement two input-based adequacy approaches, the professional judgment (PJ) and evidence-based (EB) approaches, that both heavily rely on the expertise and experience of Colorado educators to identify resources and provide policymakers with an estimate of the costs to meet these standards.
