## **Boulder Valley School District (BVSD)**

- 30,000 students, 37 elementary, 19 middle, 16 high school
- BVSD covers 500 square miles
- BVSD offers High School and Middle School Sports Programs
- 32 Male and Female Sports offerings (High School)
- 13 Male and Female Sports offerings (Middle School)
- Approximately 1,100 Students Participate in High School Sports Programs

# **Athletic Review Committee (ARC)**

- Board Created the Committee in 2017
  - Initial purpose was to create a survey for families of athletes
- Membership has evolved over time
- District Level Athletic Director was hired in July 2021
- ARC is Advisory to the Board and the BVSD Athletic Director

#### Mission

The purpose of the Athletic Review Committee is to serve as an advisory committee to assist in identifying, reviewing, prioritizing, and providing recommendations to the District Athletic Director regarding the direction of BVSD high school athletic programming. We aim to deliver diverse, inclusive, and equitable opportunities for all student athletes.

# Who Are We?

- The Colorado High School Activities Association (CHSAA) is the governing body for all high school activities throughout the state of Colorado.
- We were founded in 1921, and as of the 2023–24 school year we have a membership of 367 full-time high schools, plus more than 50 middle and junior high schools, for a total of more than 400 schools.
- The Association holds championships for 29 different sports for both boys and girls, plus competitions in esports, music, sportsmanship, student council, and spirit.

# Legislative Council – What is it?

- The "Legislative Authority" of the association
- Given the authority to establish Bylaws and rules
- Can make amendments to the Constitution & Bylaws
- Represents the entirety of the "membership"
- Works symbiotically with the Board of Directors as the "voice" of the membership

# Legislative Council – Who is it?

- School representatives eligible to serve on the Legislative Council are limited to superintendents, district athletic directors, principals, athletic directors, activities directors or other designated administrative personnel, including members of Boards of Education and members of private school governing boards.
- Representatives are elected by the league
- Number of representatives is based on the number of schools in your league
- Representatives from; CASE/CASSA, CASB, CADA
- sen from the membership of the BOD

## **Board of Directors**

The BOD consists of the CHSAA Commissioner (as a non-voting member), the State Commissioner of Education or his/her/their appointee, the President of the Colorado Association of School Boards or his/her/their appointee, a current elected member of the Colorado State Legislature appointed by the CHSAA Board of Directors, two (one principal, one superintendent) representatives of the Colorado Association of School Executives (CASE), the President, a member from each of 10 districts, and 3 At-Large members. At-Large members must be a woman and one representative chosen from historically marginalized communities (Black/African-American, Hispanic/Latinx, or Native American/American Indian/Indigenous American).
